Qualifications	<ul style="list-style-type: none"> • A Daughter must NOT have reached her 20th birthday on or before the day of competition. • Daughters may enter only one INDIVIDUAL category. • For team entries a Jurisdiction needs to choose from ONE of the categories below: <ul style="list-style-type: none"> ○ Jurisdictional (State/Province)Team <ul style="list-style-type: none"> ▪ East State/Province may enter only 1 Daughter Messenger Team and only 1 Majority Team. Members may be from across the entire jurisdiction. OR ○ Area/Association/Regional Teams <ul style="list-style-type: none"> ▪ A Jurisdiction can decide to enter more than 1 Daughter Messenger Team and Majority Member Team. Members must be from the same Area/Association/District. This option is not allowed if a Jurisdictional Team is entered.

Nail Polish**

Due to the many variations amongst Countries and Jurisdictions we ask that **NO Jewelry or Nail Polish be worn.** If a girl has artificial nails, we will accept them with white tips.

Individual Categories (Except Story of Job) Will include Station and Duty, initiation part, all floor work for the respective station, if any, and **Will** give instructions to Guide, Marshal, HQ or any others.

Team Categories: Messenger Teams will **NOT** include Station and Duty. Team members **WILL** give all instructions to the Guide and Marshal. The team will give all initiation work and floor work for their respective station

Story of Job: Will give all initiation work and will **NOT** include Station and Duty and will **NOT** give instructions to the Guide and Marshal.

All Categories:

- Pay attention to floor work, hand positions, sitting, as per instructions in Ritual.
- The Daughter may enter and leave the competition room in any manner she chooses.
- Before entering the competition room, the door monitor will give the competitor(s) information regarding prompting and any other instructions. The Competitor(s) may ask questions at this time.

There will be NO spectators allowed in competition rooms.

NOTE: The Ritual we are using has the JDI logo on the cover and a 2011 revision date on page 3. The Proficiency we are using is the 2011 Proficiency Lessons.

<p>Jobie-to-Bee</p>	<p>Jobie-2-Bee will sit in the 5th Messenger's chair. Stand up at the 5th Messengers chair and recite the Friendship Poem. Bee should be seated when she is finished. She will be excused upon completion of her part.</p> <p style="text-align: center;">JOBIE-2- BEE POEM</p> <p>A friend is someone we turn to when our spirits need a lift. A friend is someone we treasure for true friendship is a gift.</p> <p>A friend is someone filling our lives, with beauty, joy and grace. A friend makes the world we live in a better, happier place.</p> <p>(Jobie-to-Bee shall wear any outfit in keeping with the ideals of JDI)</p>
<p>New Member Obligation Mother's, Father's and Guardian's Prayer</p>	<p>Daughter will begin by sitting in the 5th Messenger's chair, walk forward and kneel down at the altar, assume the attitude of prayer and give the Obligation and/or Mothers Fathers and Guardians' Prayer. She will then rise and back up to the 5th Messenger's chair and be seated.</p> <p>*Please mark on the entry form if the New Member wants to compete in the category Obligation only, Mothers, Fathers, and Guardian's Prayer only, or if she wants to recite both.</p>
<p>Messengers</p>	<p>Rise. Give station and duty. Take position for initiation part, as per Ritual, with instructions to Guide and Marshal. Return to station as per Ritual and be seated signifying the completion of the competition.</p> <p>Station and Duties, and initiation parts as follows:</p> <p>1st Messenger pages 41, 90-91 2nd Messenger pages 41, 91-92 3rd Messenger pages 41, 95-96 4th Messenger pages 42, 97-98 5th Messenger pages 42, 101-102</p>

<p>Chaplain</p>	<p>Rise and give station and duty (page 43). Approach Altar and open Bible as per ritual. Then give initiation part (page 88 including Obligation - Proficiency work No. 1) and all prayers (Initiation prayer page 108; Mothers', Fathers' and Guardians Prayer - Ritual page 66; Closing prayer Ritual page 68), kneeling and rising as specified. At conclusion of Closing Prayer rise and close Bible. Return to station and be seated signifying completion of competition.</p>
<p>Story of Job</p>	<p>Begin seated in the 1st Messenger's chair, approach the altar and recite all 5 messenger lectures and upon completion be seated in the 5th Messenger Chair. NO INSTRUCTIONS TO THE GUIDE AND MARSHAL SHALL BE GIVEN. The daughter does not say the station and duties part during the Story of Job competition. Ritual pages: 90-91, 91-92, 95-97, 97-98, 101-102</p>
<p>Messenger Team And Majority Member Team</p>	<p>Ritual Teams will enter, assume their respective stations and be seated. The team will be told they may begin and the Messengers will, in turn, approach the Altar, as per Ritual, give initiation part and be seated. No prompts from the ritual will be given. Competition will conclude when 5th Messenger returns to her seat and is seated. INSTRUCTIONS TO THE GUIDE AND MARSHAL NEED TO BE GIVEN Ritual pages: 90-91, 91-92, 95-97, 97-98, 101-102 & Plates 25-27-29</p> <p>NOTE: If your Daughter Messenger team is not selected by June 15th, please mail in a form including the date that you will be selecting your team. Then send in the Daughters names to complete the information by June 30th.</p> <p>(Appropriate attire for Majority Member Team competitors is dress or skirt and blouse.)</p>
