The attached application and letter of intent need to be filled out and submitted to the Grand Bethel Guardian no later than February 10, 2025. Applications received after this date will not be considered. The Grand Bethel Advisory Committee will be reviewing applications and choosing 2 Daughters to represent Idaho.
